Usage precautions

For professional users only. Read and follow manufacturer's recommendations. Wear protective clothing as described in Section 8 of this safety data sheet. Keep away from food, drink and animal feeding stuffs. Avoid exposing aerosol containers to high temperatures or direct sunlight. The product is flammable. Keep away from heat, hot surfaces, sparks, open flames and other ignition sources. No smoking. Do not handle until all safety precautions have been read and understood. Do not handle broken packages without protective equipment. Do not spray on an open flame or other ignition source. Pressurized container: Do not pierce or burn, even after use. Spray will evaporate and cool rapidly and may cause frostbite or cold burns if in contact with skin. Avoid contact with eyes.

Store at temperatures between 10°C and 25°C. Store away from incompatible materials (see Section 10). Store in accordance with national regulations. Keep away from oxidising materials, heat and flames. Keep only in the original container. Keep container tightly closed and in a well-ventilated place. Keep containers upright. Protect containers from damage. Protect from sunlight. Do not store near heat sources or expose to high temperatures. Do not expose to temperatures exceeding 50 °C/ 122 °F. Bund storage facilities to prevent soil and water pollution in the event of spillage. The storage area floor should be leak-tight, jointless and not absorbent.

Appropriate engineering controls	Provide adequate ventilation.
